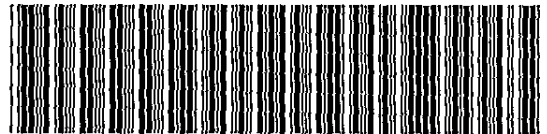

The mailing address and street address of the principal office of the Company is 1195 Sioux Circle, Crestview, Florida 32536.


ARTICLE III - Registered Agent and Office
