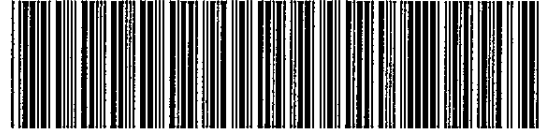

ARTICLES OF ORGANIZATION
OF
FIRST CHOICE PATHOLOGISTS, LLC

The undersigned hereby form and establish a Limited Liability Company pursuant to Chapter 608, Florida Statutes, as follows:

ARTICLE I

The name of this Limited Liability Company is FIRST CHOICE PATHOLOGISTS, LLC.

ARTICLE II
