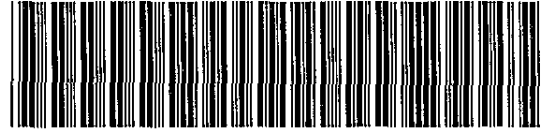



**ARTICLES OF ORGANIZATION  
OF  
ACTIVE 911 LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I**

The name of this limited liability company is ACTIVE 911 LLC ("Company").
