ARTICLES OF ORGANIZATION OF MSP, L.L.C. A FLORIDA LÍMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLET

Name. The name of the limited liability company shall be MSP, L.L.C.. ("Company").


