### ARTICLES OF ORGANIZATION

OF

## AJC ENTERPRISES, LLC

The undersigned, for the purpose of forming a limited liability company and the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be AJC ENTERPRISES, LLC, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 3313 West Marcum Street, Tampa, Florida 33611 and the mailing address shall be the same.
