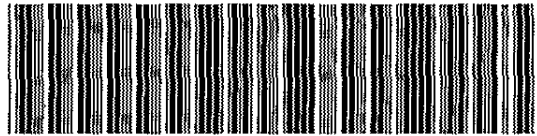



SECOND: The effective date of the limited liability company's dissolution is the date of the filing of these Articles of Dissolution.


THIRD: The limited liability company was dissolved upon this written consent of both of the members of Coquina Title, LLC., dated July 7, 2006.

FOURTH: As of the date of these articles, all debts, obligations, and liabilities of Coquina Title, LLC have been paid or discharged.


FIFTH: All the remaining property and assets have been distributed among the members of Coquina Title, LLC according to their respective rights and interests.
