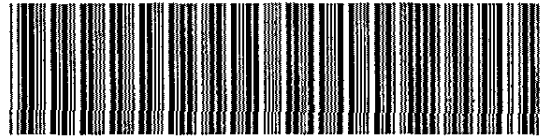

Name


