Articles of Organization of

3216 SW 8th Court, LLC,

a Florida Limited Liability Company

The undersigned, William C. Bissett, desires to form a limited liability company pursuant to the Florida Limited Liability Company Act. As one of the members of the proposed limited liability company, she does hereby make and file these Articles of Organization, and hereby declares and affirms:

ARTICLE I: Name

ARTICLE II: Duration and Purpose
