ARTICLES OF ORGANIZATION

OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

ARTICLE I - NAME:

The name of this limited liability company is STERLING BREEZE, LLC (the "Company").
