ARTICLES OF ORGANIZATION



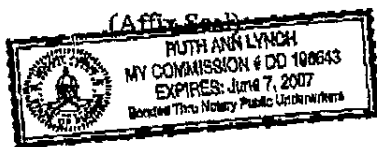


