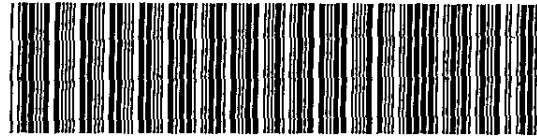



**ARTICLES OF ORGANIZATION OF
PHILLIP W. STANGELAND, LLC**

(Pursuant to Section 608.407, Florida Statutes)

ARTICLE I - NAME

The name of the limited liability company is PHILLIP W. STANGELAND, LLC.

ARTICLE II - ADDRESS

The mailing and street address of the company is 5308 Conecuh Street, Milton, Florida 32570.

ARTICLE III - PURPOSE

The company has been organized for commercial development and any other lawful business.

ARTICLE IV - INITIAL MEMBERS

ARTICLE V - TRANSFER OF INTERESTS

ARTICLE VI - REGISTERED AGENT


CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE
