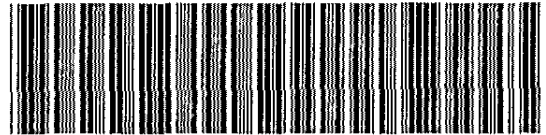

**ARTICLES OF ORGANIZATION



#### ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS


