ARTICLES OF ORGANIZATION OF JOAN B. PINCUS, MD, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability Company shall be JOAN B. PINCUS, MD, LLC ("Company"). The principal office of the Company in Florida shall be 10313 S.W. 48th Place, Gainesville, Florida, 32608.

ARTICLE II - DURATION

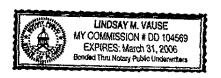
