- 1. Name. The name of this limited liability company is WATERMARK REALTY GROUP, LLC (the "Company"), and it shall be formed as a limited liability company under the Florida Limited Liability Company Act.
- 2. <u>Existence</u>. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.
- 3. <u>Principal Place of Business</u>. The mailing address of the Company's principal place of business is 1270-B Estero Blvd., Fort Myers Beach, FL, 33931.
- 4. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including real estate investments.
