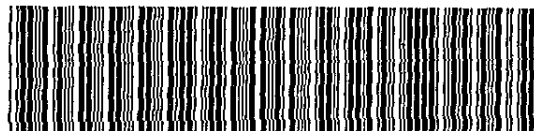




The effective date of the limited liability company is October 6, 2004.


