STATE OF THE STATE The undersigned, for the purpose of forming a limited liability company under the Flor Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be TeleRad, LLC, ("company

ARTICLE II - ADDRESS
