

## ARTICLES OF ORGANIZATION

OF

DMMS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

### Article I – Name

The name of this limited liability company shall be DMMS, LLC.

### Article II – Address

### Article III – Duration

**Article VI – Members' Right to Continue Business**


