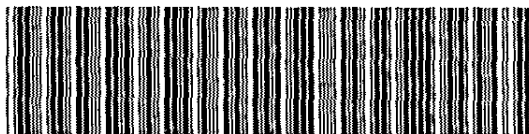

**EL-AD TUSCANY POINTE II LLC**


2. The filing date of the Articles of Organization of the Company was October 11, 2004, under Document No. L04000073821.
