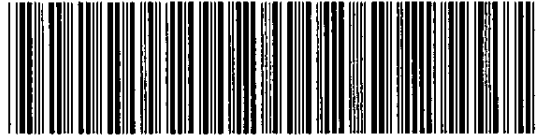

This Articles of Conversion is submitted to convert EL-AD TUSCANY POINTE II LLC, a Florida limited liability company, into EL-AD TUSCANY POINTE II LLC a Delaware limited liability company (the "Other Business Entity"), in accordance with Section 605.1045, of the Florida Revised Limited Liability Company Act.

1. The name of the Florida limited liability company converting into the Other Business Entity is EL-AD TUSCANY POINTE II LLC ("EATP").

2. The name of the Other Business Entity is EL-AD TUSCANY POINTE II LLC (the "Company").
