THIRD: The mailing address and street address of the principal office is 20811 Groveline Court, Estero, FL 33928.


FOURTH: The name and street address of the registered agent within the State of Florida is Byron Fisher, 20811 Groveline Court, Estero, FL 33928.



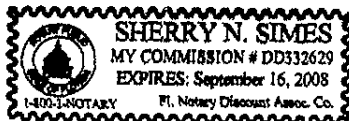


