1. **NAME**

3. **PURPOSE**

Members may, with the consent of the Manager, adopt, alter, amend or repeal any provision of the Articles of the Organization upon the affirmative vote of the Manager and a majority in interest of the members of the Company which vote is taken at a duly called meeting of the members at which a quorum is present, or by written consent of the members of the Company.

**12. REGULATIONS**

Pursuant to Section 608.423(1) of the Act, the members of the Company, with the consent of the Manager, may adopt, alter, amend or repeal regulations or any provision thereof, upon the affirmative vote of the Manager and a majority in interest of the members of the Company in attendance at a meeting of the members duly called at which a quorum exists, or by written consent of the members of the Company.




