## ARTICLES OF ORGANIZATION

OF

# LHW DISTRIBUTION, LLC

The undersigned, for the purpose of forming a limited liability company funder the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be LHW DISTRIBUTION, LLC, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1995 East Hallandale Beach Boulevard, Number 200, Hallandale, Florida 33009 and the mailing address shall be the same.

#### ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### **ARTICLE 4 - DURATION**
