

ARTICLE V – Vote-Out Provision:

The Vote-Out Provision states: Should any manager not perform as agreed to pursuant to the Manager(s) agreement, the majority of existing Manager(s) **MUST** vote as to a Manager’s buyout.

ARTICLE VI – Buyout Price Provision:

The Buyout Price is the provision that states: (a) Should any manager not perform as agreed to pursuant to the Manager(s) agreement, the majority of existing Manager(s) **MUST** vote as to a Manager’s buyout. The buyout price will be equal to one (1) month of wages, which shall be paid to the dissociating Manager upon the conclusion of his or her involvement with Red Point Construction, L.L.C. In winding up the dissociating Manager’s business, all of his or her liabilities must be paid before any amount is distributed to the dissociating Manager, thus the buyout price is the net of all known liabilities. (b) Should any Manager decide that s/he wishes to be dissociated as a Manager of Red Point Construction, L.L.C., the remaining Manager(s) will abide by the buyout price provision stated in Article VI, section (a) above.

ARTICLE VII – Acceptance of New or Additional Manager(s):

The acceptance of new or additional Manager(s) requires the agreement of the majority

current Manager(s). No new or additional Manager shall be bound by any or all liabilities then held by Red Point Construction, L.L.C. prior to his/her acceptance of Manager unless otherwise agreed to in a separate document executed by all existing current Manager(s).
