

**ARTICLES OF ORGANIZATION OF
SMA PROPERTIES, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida sets forth the following:

ARTICLE I: NAME

The Name of the Limited Liability Company is: SMA Properties, LLC

ARTICLE II: ADDRESS

The Mailing Address of the Principal Office is: 622 Downs Avenue, Temple Terrace, Florida 33617.

The Street Address of the Principal Office is the same.

ARTICLE III: DURATION

The duration for the Limited Liability Company shall be perpetual.

ARTICLE IV: MANAGEMENT
