**ARTICLES OF ORGANIZATION  
OF  
COMMUNITY CANCER CENTERS OF BREVARD, LLC**

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

**ARTICLE I - NAME**

The name of this limited liability company shall be Community Cancer Centers of Brevard, LLC (the "Company").
