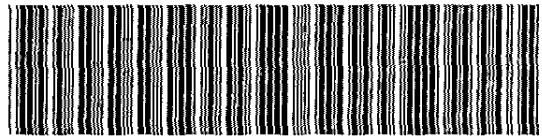

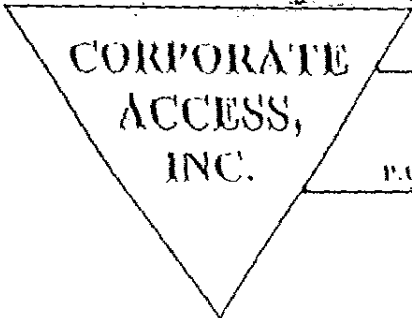

ARTICLE IV





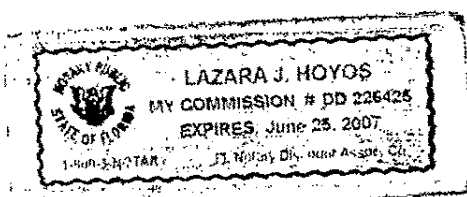
