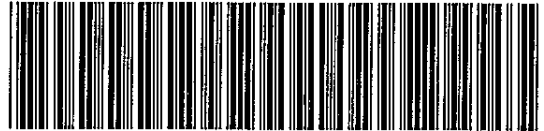

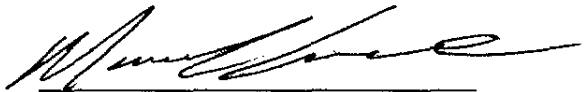
**ARTICLE IV – Initial President's Authority to
