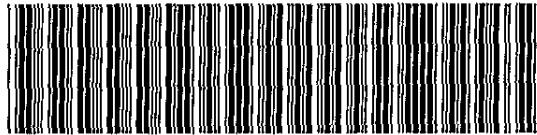

(Initial Manager)




