AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
I PATHOLOGY, LLC

The Articles of Organization of I PATHOLOGY, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on October 15, 2004 under Document Number L04000075024. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is I PATHOLOGY, LLC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - REGISTERED OFFICE AND AGENT

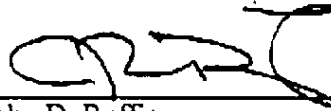
