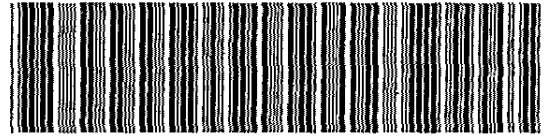

**ARTICLES OF ORGANIZATION
OF

Article I Name
