ARTICLES OF ORGANIZATION
of
LOT 14 UTAH, L.L.C.

The undersigned, being a duly authorized person, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I
DURATION

LOT 14 UTAH, L.L.C. shall exist perpetually or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

ARTICLE II
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be LOT 14 UTAH, L.L.C., and its principal and mailing office shall be located at 112 Lansing Island Drive, Indian Harbor Beach, Florida 32927, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.
