**ARTICLES OF ORGANIZATION
OF

The undersigned member hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

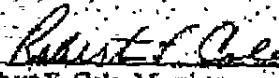
ARTICLE V**Operating Agreement**

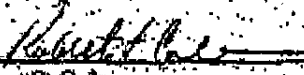
