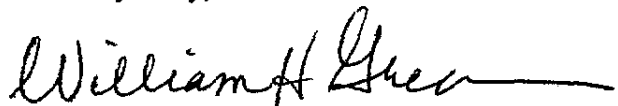

ARTICLES OF ORGANIZATION

ARTICLE IV - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

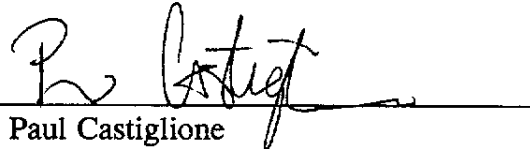
The initial registered office shall be at 664 Baldwin Avenue, DeFuniak Springs, Florida 32435, and the initial registered agent shall be William H. Green.

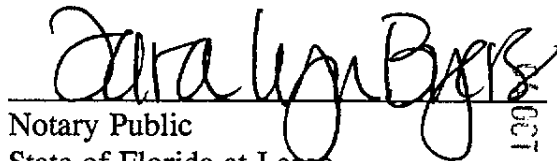
