# ARTICLES OF ORGANIZATION OF GERDA & ASSOCIATES, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

## **ARTICLE I - NAME**

The name of the limited liability company shall be **GERDA & ASSOCIATES**, L.L.C. ("Company").

## ARTICLE II - ADDRESS
