AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

MAKO'VER, LLC

The undersigned, for the purpose of amending and restating the Articles of Organization of MAKO'VER, LLC have duly executed these Amended and Restated Articles of Organization pursuant to the provisions of §608.411, Florida Statutes. and state:

- A. The limited liability company's present name is Mako'ver, LLC.
- B. The Articles of Organization for the limited liability company were origin filed July 14, 2004, under the name Fix'n Chick'n Holding, LLC.
- C. The effective date of these Amended and Restated Articles of Organization shall be the date of filing.

AMENDED AND RESTATED ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE 1 - Name

I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, Fla. Stat.

ARTICLE 4 - Managers

ARTICLE 5 -Term of Existence and Members Rights to Continue Business

The Company shall commence its corporate existence on the date these Articles of Organization are filed by the Florida Department of State, and shall be perpetual thereafter until dissolved by the unanimous agreement of all Members. The death, bankruptcy or

dissolution of a Member shall not cause the dissolution of the Company, and the business of the Company shall continue without the consent of any of the remaining Members.

ARTICLE 6 - Purposes and Powers
