The undersigned, for the purpose of amending and restating the Articles of Organization of MAKO'VER, LLC, now known as REEL PALS, LLC, have duly executed these Second Amended and Restated Articles of Organization pursuant to the provisions of §608.411, Florida Statutes. and state:

- A. The limited liability company's present name is Reel Pals, LLC.
- B. The Articles of Organization for the limited liability company were originally filed July 14, 2004, under the name Fix'n Chick'n Holding, LLC, which was subsequently changed on June 23, 2008, to Mako'ver, LLC, pursuant to the filing of Amended and Restated Articles of Organization.
- C. The effective date of these Second Amended and Restated Articles of Organization shall be the date of filing.

SECOND AMENDED AND RESTATED ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE 1 - Name

The name of the limited liability company shall be Reel Pals, LLC (hereinafter "Company").

ARTICLE 2 - Address of Company

The mailing address of the Company is P.O. Box 823, Windermere, FL 34786-0823 and the street address of the principal office of the Company is 224 E. 7th Avenue, Windermere, FL 34786.

ARTICLE 3 - Initial Registered Office and Agent, and Agent's Signature

Having been named as the registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in that capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, Fla. Stat.

ARTICLE 4 - Managers

Subject to the limitations set forth in the Operating Agreement, if any, the business and affairs of the Company shall be managed by three Managers, appointed in accordance with the Operating Agreement of the Company, who may exercise all powers of the Company and perform or authorize the performance of all lawful acts which are not otherwise prohibited by law, the Operating Agreement or these Articles of Organization. All acts of the Managers within the scope of their authority shall be binding on the Company. Each Manager shall be required to be a Member of the Company or the appointed agent of a Member, but shall not be required to be a resident of the State of Florida. The Company shall initially be managed by three Managers. The method of appointing, removing and replacing such managers shall be prescribed by the Operating Agreement. The number of managers may be increased or decreased from time to time by the Operating Agreement. The Company shall commence its corporate existence on the date these Articles of Organization are filed by the Florida Department of State, and shall be perpetual thereafter until dissolved by the unanimous agreement of all Members. The death, bankruptcy or dissolution of a Member shall not cause the dissolution of the Company, and the business of the Company shall continue without the consent of any of the remaining Members.

ARTICLE 6 - Purposes and Powers

The general purpose for which the Company is organized is to own and operate an offshore fishing boat, and to transact any and all lawful business which a limited liability company may be organized under the laws of the State of Florida and of the United States. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE 7 - Amendment to Articles

These Articles of Organization may only be amended by two thirds of the members by capital account.
