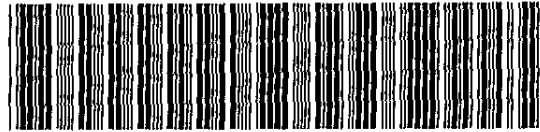

ARTICLE I

MANAGEMENT

The Company shall be a Manager-managed Company.


ARTICLE VIII

AMENDMENT TO ARTICLES OF ORGANIZATION

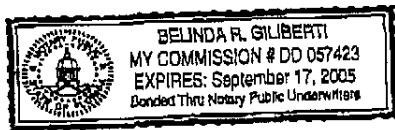




