3. Purpose. The purpose for which the LLC is organized is to engage in any and all activities permitted by law.

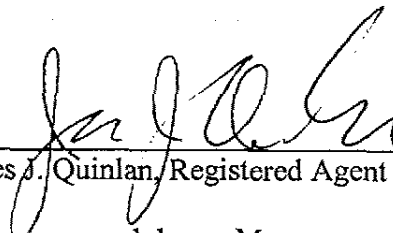

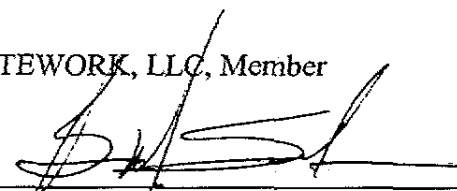
