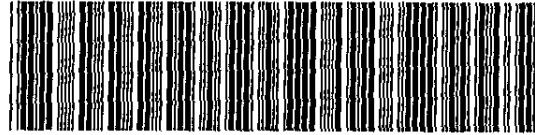

The Company is authorized to transact any business permitted by the laws of the State of Florida for a Limited Liability Company.

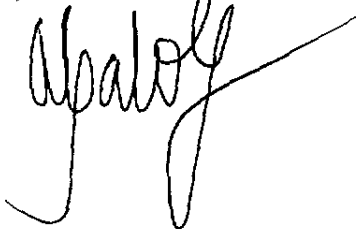
ARTICLE IV. DURATION

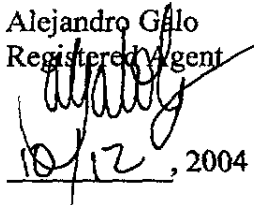
