ARTICLES OF AMENDMENT

OF

WXEL COMMUNITY FOUNDATION, INC., A FLORIDA NOT FOR PROFIT CORPORATION

(Document Number N04000008901)

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned, Florida non profit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: ARTICLE I, entitled **NAME AND PLACE OF BUSINESS** is amended to read as follows:

"The complete legal name of the corporation is **COMMUNITY BROADCAST FOUNDATION OF PALM BEACH AND THE TREASURE COAST, INC.**

The principal place of business of this corporation shall be 700 North Olive Avenue, West Palm Beach, Florida 33401."
