ARTICLES OF ORGANIZATION OF BBH RADIO, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

ARTICLE V - CAPITAL CONTRIBUTIONS

ARTICLE VIII - TRANSFER OF MEMBER INTEREST UPON DEATH OF MEMBER; TERMINATION OF EXISTENCE

In the event of death of a member, that member's unit interest in the Company shall pass to the member's heirs and beneficiaries described in the deceased member's will

and/or trust. The surviving member shall serve as the sole member/manager of the Company after the death of an initial member.

The company shall be dissolved on the death, bankruptcy, insanity, retirement, resignation, expulsion or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the company is continued by the consent of all the remaining members, provided there is at least one remaining member.

ARTICLE IX - MANAGEMENT

The Company shall be managed by a member/manager designated by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
