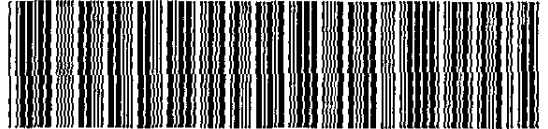


ARTICLE 6




