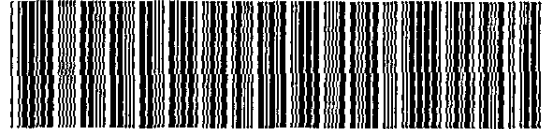


## ARTICLE 6


