ARTICLES OF ORGANIZATION

OF

9901 SUBURBAN DRIVE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE I

Name

The name of the Company is 9901 Suburban Drive, LLC. The street address of the principal office of the Company and the mailing address of the Company are c/o Spencer and Klein, P.A., Penthouse IIB, Two Alhambra Plaza, Coral Gables, Florida 33134.

ARTICLE II

Duration
