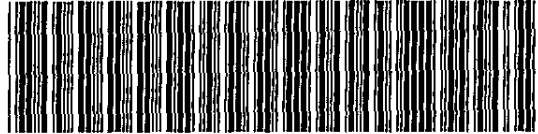

ARTICLE IV- Manager(s) or Managing Member(s):

ARTICLE V- The effective starting date for Protech Consulting Group, LLC shall be November 1, 2004.

ARTICLE VI- Each of two Managing Members has capitalized this LLC equally and shall have a 50% interest in it. Decisions normally requiring a vote will be made by consensus. The original contribution to this LLC was in the amount of \$250 each for a total of \$500.

ARTICLE VII- The addition of any more Members, Managing Members or Managers will require a rewriting or revision of these Articles of Organization to clarify capitalization amounts, voting rights and decision making protocol.

ARTICLE VIII- The purpose of this LLC is to carry on or undertake any business, activities, or transactions in the State of Florida, or in any other State of the United States, or in any foreign country, which an LLC may lawfully carry on or undertake under the General Business Organization Law of Florida and under the laws of such other states or foreign country.

ARTICLE IX- As concerns identification of Company duties and use of titles:

- 1. Mr. Rothbaum is assigned the duties normally associated with the president and treasurer roles. He is responsible for maintaining the LLC's financial records. He will file the required Annual Report to the Florida Department of State. He may use the title of "President" or "Principal".**
- 2. Mr. Kauffman is assigned the duties normally associated with the vice-president and secretary roles. He may use the title of "Vice-President" or "Principal".**

ARTICLE X- Termination Rights:

1. Either of the two Managing Members shall have the right to withdraw his position as Managing Member and Officer of this LLC within 30 days of written notice to the other Managing Member. He shall receive any monies or property already owed to him plus one-half (50%) of the net assets of the LLC within 90 days of his effective resignation. Net assets shall include accounts receivable.
2. Either of the two Managing Members shall have the right to dissolve this LLC within 90 days of written notice to the other Managing Member. Net assets shall be dispersed on a 50 – 50 basis to the two Managing Members.
