**ARTICLES OF ORGANIZATION

**ADDITIONAL MEMBERS**

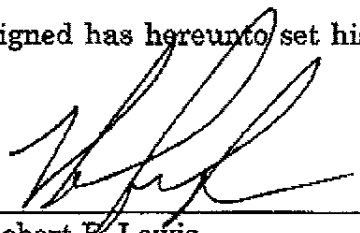
