The Limited Liability Company is to be managed by a Manager selected by the members and is, therefore, not a member managed Company.



Assignment


Upon filing of these Articles of Organization with the Florida Department of State, the undersigned Member may assign all or a part of his membership rights in and to the Company to one or more members.
