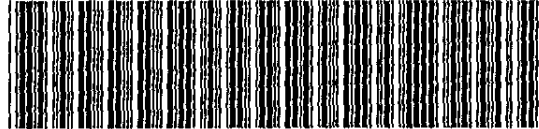

**ARTICLES OF ORGANIZATION

**ARTICLE I - NAME**
