8. Amendment of Articles of Organization;

Any amendment to those Articles of Organization shall be on such form prescribed by the SEE, FLORID! Secretary of State of the State of Florida containing such terms and provisions consistent with Florida Statute 608 as shall be prescribed by the Department of State, and shall be signed and sworn to by all Members of the Company. In the event a new member is added by such amendment, it shall be also signed by the member to be added.

Regulations of Company:

The power to adopt; eiter, amend or repeal the regulations of the limited liability company shall be vested in the Members unless vested in the Manager(s) of the company by any amendments of the Articles of Organization.
