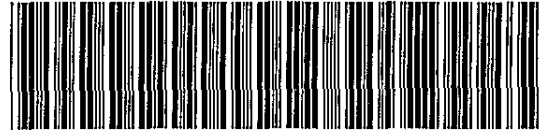



The undersigned, being the sole member of BAY/FT. MYERS LLC, a Florida limited liability company (the "Company"), hereby authorizes by consent, the following action:


RESOLVED, that the Company be, and it hereby is authorized to be dissolved effective as of the 24th day of May, 2005.
